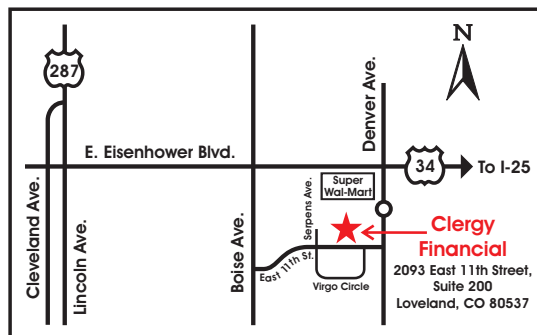


Tax Appointment Locations

From I-25: Take Exit 257B (US Hwy 34 West), go 2.7 miles west to Denver Avenue and turn left (south). Continue through the roundabout (use the left lane to stay on Denver Ave. going south). Turn right (west) on East 11th Street. We are located on the right side of the street. The entrance is on the east side of the building. Suite 200 is the whole second floor.



From US Hwy 287 South of Loveland:

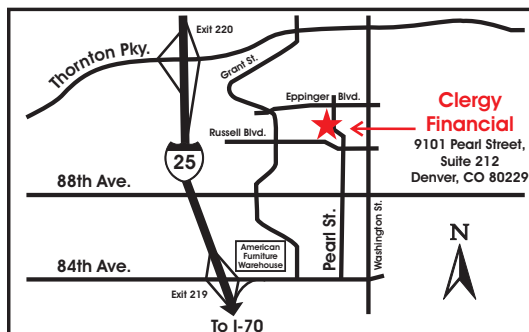
Go North on Lincoln Avenue (US Hwy 287) to Eisenhower Blvd (US Hwy 34) and turn right (east). Continue 1 mile to Boise Avenue and turn right (south). Continue to East 11th Street and turn left (east) on East 11th Street. We are located on the left side of the street after the 4-way stop. The entrance is on the east side of the building. Suite 200 is the whole second floor.

From US Hwy 287 North of Loveland: Go South on Cleveland Avenue (US Hwy 34) to Eisenhower Blvd (US Hwy 34) and turn left (east). Go 1 mile to Boise Avenue and turn right (south). Continue on Boise Avenue to East 11th Street and turn left (east). We are located on the left side of the street after the 4-way stop. The entrance is on the east side of the building. Suite 200 is the whole second floor.

From I-25 Northbound: Take Exit 219 (84th Avenue) going east on 84th Avenue to Pearl Street and turn left (north). (If you miss Pearl St. turn left on Washington, left on Russell Blvd, then right on Pearl St.) Continue on Pearl St. through the traffic light at 88th Ave. The building is on the left side of the street with parking on either side. Suite 212 is on the second floor.

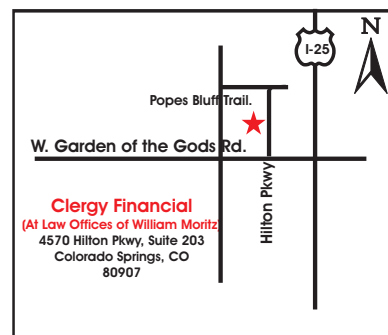


From I-25 Southbound: Take Exit 220 (Thornton Parkway) East. Go east on West Thornton Parkway to Washington and turn right (south). Continue to East Eppinger Blvd and turn right (west). Go a block or two to Pearl Street and turn left (south). The building is on the right side of the street with parking on either side. Suite 212 is on the second floor.
